- IN AN EMERGENCY:** I authorize any First Aid Responders and/or Physicians to perform any and all medical procedures, which he/she determines to be medically appropriate under the circumstances.
- MEDIA COVERAGE:** During any GYC activity, media coverage (photography, interviews) may occur. Please check the box if you do not consent to your child’s picture being taken/posted/advertised in support of the GYC.
- I understand that members and parent/guardians are ultimately responsible for the arrival and departure at the GYC. Members are able to sign in and out and leave the premises.

**BASIC MEMBER RESPONSIBILITIES**

**CLEAN-UP** – During designated times, there will be a clean-up period, where all activity will be suspended. All present members are required to assist in the clean-up process. Clean-up is usually about 15 minutes.

**SIGN-IN/OUT** – All members are required to sign in and out. Members are required to write correctly and legibly the name under which their application is under. Failure to do so will result in ejection from the GYC. This is for the safety of all members.

**PERSONAL PROPERTY** – We have designated space for backpacks and coats and extra personal items. Be sure to place them in the designated area. **GYC not responsible for lost/damaged personal property.**

**3 Strike Rule** - Minor problems: 5 to 30 minutes TIME OUT will be issued. (MULTIPLE MINOR PROBLEMS WILL RESULT IN A STRIKE). 1ST OFFENSE - Incident form is filled out, parents are notified, and the child is warned that if behavior continues, he/she will be removed from the youth center for 1 week. 2ND OFFENSE - Incident form is filled out, parents are notified, and the child is removed from the youth center for one month. (member must perform Junior Volunteer hours before full membership reinstated. To be determined by GYC Staff) 3RD OFFENSE - Incident form is filled out, parents are notified, and the child is removed from the youth center for six months.

**IMPORTANT NOTE:** *If incidents persist following the 3rd strike, GYC membership will be revoked indefinitely.*
